TERMS & CONDITIONS FOR BIOSPAIN 2016

1. ORGANISATION

BIOSPAIN 2016 is organised and managed by ASEBIO (Spanish Bioindustry Association) and SPRI (Business Development Agency of the Basque Government)

2. VENUE, DATE & TIME

BIOSPAIN 2016 is to be held in Hall 1 of the Bilbao Exhibition Centre in Barakaldo (Spain) on September 28-30, 2016. Stands must be staffed and the materials exhibited must be on display throughout the opening hours.

Entry of exhibitors: half an hour before opening time. Departure of exhibitors: half an hour after closing time.

3. EXHIBITORS

All individuals, legal persons, public and private sector organisations whose activities are considered to fall within the sectors covered by the event may apply to take part in it.

4. CONTRACTS

- 4.1 Contracts will be drawn up within 7 days of due completion of the application form and payment of the relevant fee.
- **4.2**. The deadline for applications for preferential registration is June 3, 2016. Such applications will be granted in accordance with demand and with the space available.

5.2. The participation fee must be paid in full upon formalisation of registration, and no later than September 10, 2016.

6. TERMS & CONDITIONS OF CANCELLATION

Any applicant that declines to participate before July 8 must inform BIOSPAIN's Technical Secretariat biospain@bec.eu to receive a 50% refund (minus bank transfer charges). Refunds will be processed after BIOSPAIN 2016. After July 8, 2016, the full registration fee is applicable.

7. COMPULSORY INSURANCE

ASEBIO will contract insurance for this event as follows:

- **7.1**. Civil liability. Basic cover:
 - Material damage & bodily harm caused to third parties as a result of the event, expressly excluding civil liability arising from occupational accidents suffered by personnel employed and/or subcontracted by the exhibitor.
- Limit of compensation €1,200,000 per insured loss with a sub-limit of €150,000 per victim for personal injury.
- **7.2.** The organisers will provide a video-camera surveillance and monitoring service for the exhibition area. At no time will the Organiser accept liability for any damage or theft of any article on the stand of the exhibitor.
- **7.3.** For objects of great value or special interest, BEC has a secure storage service that can be requested from the services office in the main building.

8. OFFICIAL CATALOGUE

An official catalogue for BIOSPAIN 2016 will be produced. Exhibitors will receive a form with guidelines of how to present their company details.

The deadline for the receipt of these forms is July 29, 2016 (29/07/16). Exhibitor information received after this date won't be published

9. ERECTION WORK, ENTRY OF GOODS & DISMANTLING

Days for erection work & entry of goods: Monday September 26 from 8.00 to 20.00, Tuesday September 27 from 8.00 to 15.00. Exhibitors may access their stands to unload materials, but must then remove vehicles from the aisles and take them outside the hall itself and outside the perimeter of the exhibition halls (unless expressly authorised by the event organisers to do otherwise) as soon as unloading is completed. Vehicles may be left in the exhibition centre car-park (car-park cards will be provided).

<u>Stand decoration may be completed on Tuesday September 27, 2016 from 15.00 to 20.00.</u> On this day, vehicle access to the venue is prohibited, so that it can be thoroughly cleaned. Any exhibitor that wishes to unload on that day may take their vehicle only as far as the hall door set aside for this purpose, or may access the hall via the car-park.

<u>Commencement and completion of dismantling work</u>: Stands may be dismantled on Saturday October 01 from 8.00 to 20.00. Vehicle access to stands is permitted on that day.

Exhibitors must comply with all applicable provisions on the prevention of accidents and fires, and must hold the relevant erectors' cards duly completed for the exhibition hall access control point.
